QUALIFICATION FOR ELECTION TO THE STUDENTS' COUNCIL

A person is qualified to be nominated as a candidate for election to the Students' Council if that person:

- i. is a fully paid-up member of BUCSO
- ii. is nominated by not less than 5% of total membership of each Electoral College,
- iii. has fully paid the University College fees.
- iv. is a student at the University College with at least two remaining semesters of study and has a cumulative score of not less than 60% in previous academic year's results.

DISQUALIFICATION FROM ELECTIONS TO THE STUDENTS COUNCIL

A person can be disqualified from being elected to the Students Council if that person:

- i. is a candidate for election to Congress; or College Representative (delegate),
- ii. is a member of the Student Electoral Commission, or the Students Election Appeals Committee,
- iii. has previously been removed from office for violation of the Constitution or for gross misconduct,
- iv. has been previously convicted of a criminal offence by a competent Court of Law in the Republic of Kenya or has breached the rules and regulations outlined in the Students Handbook,
- v. has received an academic warning within any of the last two semesters,
- vi. fails to attend and take part (without prior written permission from the Students' Electoral Commission) in the formal question-and-answer campaign and/or debate organized by the Students' Electoral Commission
